1 2016 by the Court of Appeals pending the outcome of a writ proceeding filed by CDCR to  
2 challenge the March 21, 2016 order. On April 22, 2016, the Court of Appeals summarily denied  
3 the writ petition. CDCR filed an *ex parte* motion in this Court on April 25, 2016 seeking, among  
4 other things, to stay the effect of the March 21, 2016 order until April 29, 2016. The Court denied  
5 that aspect of the *ex parte* motion. No stay is currently in effect. CDCR is obliged to produce the  
6 documents, but has not done so. CDCR is therefore directed to appear before this Court at <sup>3:00 PM</sup> ~~9:00~~  
7 ~~a.m.~~ on April 28, 2016 to show cause why it should not be found in contempt of this Court's  
8 March 21, 2016 order.
