**DUID VOIR DIRE**

- **CHALLENGE: JURORS BELIEVING THAT THE OPINION OF A DEFENSE EXPERT, BY ITSELF, CREATES REASONABLE DOUBT**
- **SAMPLE QUESTION: IF TWO PEOPLE CAME INTO THIS TRIAL AND GAVE YOU TWO DIFFERING ANSWERS ON THE SAME SET OF FACTS, WOULD ANYONE HERE FEEL UNCOMFORTABLE DISCERNING WHO'S RIGHT AND WHO'S WRONG?**

**DUID VOIR DIRE**

- **CHALLENGE: MANY PEOPLE ON YOUR JURY TAKE RX DRUGS AND/OR MARIJUANA**
- **SAMPLE QUESTION: DOES EVERYONE IN HERE UNDERSTAND THAT THIS TRIAL IS NOT A REFERENDUM ON RX DRUGS AND/OR MARIJUANA?**

**DUID VOIR DIRE**

- *CHALLENGE: THERE IS NO PER SE LEVEL WITH DRUGS LIKE ALCOHOL*
- *SAMPLE QUESTION: THERE IS NO PER SE LEVEL WITH DRUGS LIKE THERE IS WITH ALCOHOL. WOULD ANYONE HERE HOLD THAT AGAINST ME?*

**DUID VOIR DIRE**

- *CHALLENGE: MANY PEOPLE DO NOT CONSIDER OR REALIZE HOW MUCH EXPERIENCE AN OFFICER/DRE HAS IN DUI/D CASES*
- *SAMPLE QUESTION: WOULD YOU CONSIDER GIVING AN EXPERIENCED OFFICER MORE WEIGHT BECAUSE OF HIS B, T, E?*

**DUID VOIR DIRE**

- *CHALLENGE: MANY DUID CASES WILL CONSIST OF NO OBSERVED BAD DRIVING*
- *SAMPLE QUESTION: DOES EVERYONE IN HERE UNDERSTAND THAT THE CHARGE DOES NOT REQUIRE ME TO SHOW BAD DRIVING, BUT ONLY THE PERSON'S ABILITY TO DRIVE? ANYONE HERE NEED ME TO SHOW BAD DRIVING?*

**DUID VOIR DIRE**

- CHALLENGE: MANY DUID CASES WILL INVOKE SYMPATHY DUE TO THEIR AGE OR HANDICAP
- SAMPLE HYPOTHETICAL: BAG OF CHIPS HYPOTHETICAL WITH SYMPATHY FACTORS TOLD AFTER THE FACT.
- INFORM THE POOL THAT THE JUDGE WILL HANDLE SENTENCING

**DUID VOIR DIRE**

- CHALLENGE: MAKING AND REMINDING PEOPLE THAT WE ARE RESPONSIBLE FOR WHAT WE INGEST
- SAMPLE HYPOTHETICAL: DOES EVERYONE AGREE THAT THE RIGHT TO USE A DRUG ALSO CARRIES A RESPONSIBILITY ON WHEN AND WHERE TO USE IT?

- SAMPLE HYPOTHETICAL: BANK ROBBER HYPOTHETICAL

- *AND LASTLY, IMPROVE UPON EVERYTHING YOU'VE HEARD BECAUSE NOTHING I'M SAYING IS DEFINITIVE*
