













FACT SHEET: Harsh Drug Penalties Not Deterrent to Drug Use

In the United States, harsh penalties have not been associated with lower rates of drug use or drug dependence. Using data from the National Household Survey on Drug Use and Health, the below chart lists drug use and dependence rates for California, where drug possession is typically a felony, as well as the 13 states (and District of Columbia) where low-level drug possession is a misdemeanor offense.

In California, where the penalty for drug possession (other than marijuana) is typically a felony punishable by up to three years behind bars, drug use and dependence rates (9% and 3%, respectively) fall in the middle of the pack – higher than some misdemeanor states and lower than others.

By contrast, in Iowa – where the penalty for personal drug possession is a misdemeanor – about 6% of survey takers had used an illicit substance in the past month and just 2% were drug dependent. Meanwhile, in both DC and Vermont, where drug possession is also typically a misdemeanor offense, 11% of survey takers reported past month illicit drug use. DC's drug dependence rate was highest, at 4.25%.
