Ga. executions off: DEA seizes critical drug

ATLANTA (AP) -- All Georgia executions are off after federal drug agents seized the state's supply of a sedative used in lethal injections that has been challenged by capital punishment critics and death-row inmates, including a man recently executed who called the British exporter of the drug a "fly-by-night supplier."

Drug Enforcement Administration spokesman Chuvalo Truesdell wouldn't say exactly why Georgia's supply of sodium thiopental was taken Tuesday, just that "we had questions about how the drug was imported to the U.S." The sedative is part of a three-drug cocktail used in executions that has been in short supply since the sole U.S. manufacturer stopped making it.

No more execution dates in Georgia have been scheduled and it's unlikely any will be set before the issue is resolved. Georgia Attorney General's Office spokeswoman Lauren Kane said prosecutors couldn't ask a judge to set executions if corrections officials didn't have the necessary supplies to carry one out.

Georgia's stockpile of the drug has been a target of death row inmates and capital punishment critics since corrections officials released documents this year showing the state obtained the drug from Link Pharmaceuticals, a firm purchased five years ago by Archimedes Pharma Limited. Both are British firms.

The drug was used in January to execute Emmanuel Hammond, a 45-year-old man convicted for the 1988 shotgun slaying of an Atlanta preschool teacher. His attorneys sought a delay to gather more information on how the state obtained the drug, claiming in court documents it came from a "fly-by-night supplier operating from the back of a driving school in England." They said the drug could have been counterfeit.

The U.S. Supreme Court, as well as lower courts, rejected Hammond's argument.

The state's stockpile came under more scrutiny in February when John Bentivoglio, a former deputy attorney general, asked the Justice Department to launch an investigation into whether state corrections officials violated federal law by not registering with the DEA when it imported its supply of sodium thiopental.

"The United States has strict drug import rules for a reason: To ensure drugs used for legitimate purposes are not adulterated, counterfeit, or diverted into the illicit market," said Bentivoglio, who is representing death row inmate Andrew Grant DeYoung. Joan Heath, a spokeswoman for the Georgia Department of Corrections, said state officials were not concerned with the quality of the drug and just wanted to make sure they were complying with the law.

"We contacted the DEA and asked them for a regulatory review, and that's what we're doing," she said. "We're going to make sure we're in regulatory compliance with the DEA over how we handle controlled substances."

Hammond's attorney, Brian Mendelsohn, declined to comment.

A third death row inmate has also targeted Georgia's supply. Roy Willard Blankenship's attorneys asked a judge in February to call off his execution until the state released more details of its 20-gram supply of sodium thiopental. The complaint contended that an expired drug may not fully put Blankenship to sleep -- which could make his death extremely painful.

Blankenship's execution was delayed in February after the Georgia pardons board granted his lawyers more time to conduct additional DNA testing.

Link Pharmaceuticals didn't exist in 2010, and its name hasn't been on labels since May 2007, the lawsuit said. Sodium thiopental typically has a shelf life of four years, meaning even the state's newest supply would expire in May of this year, the lawsuit claims.

A federal judge rejected Blankenship's arguments as "nothing more than unreasonable speculation." He added that even if Blankenship could prove the supply expired, he failed to show it "creates a risk that is sure or very likely to cause serious illness or needless suffering."

The shortage has delayed executions in several states and an Associated Press review found that at least five states -- Arizona, Arkansas, California, Georgia and Tennessee -- had to turn to England for their supply of the drug. Nebraska, meanwhile, secured a stockpile from an Indian firm.

Truesdell, the DEA spokesman, said he was not certain if other states' supplies of sodium thiopental were also being collected by the agency. Officials in Arkansas and California said authorities have not seized their supplies.

Defense attorneys were elated by the news.

"We commend the DEA for forcing the Department of Corrections to immediately cease using black market execution drugs," said William Montross, an attorney with the Southern Center for Human Rights, which had sought to delay Blankenship's execution.

"It is an incredible relief that this federal agency has stepped up and intervened where the state and federal courts have turned a blind eye to the obvious problems with the procurement and use of these drugs."

# Execution drug acquired legally

The execution of a convicted murderer is the ultimate penalty imposed by the courts. The duty of the Arizona Department of Corrections is to carry out this sentence lawfully, professionally and humanely.

Recently, the media have paid increased attention to executions taking place throughout the country. Unfortunately, some of the information in these news stories is inaccurate.

The current three-drug chemical protocol used in Arizona has been upheld through the U.S. Supreme Court. Since 1993, Arizona has carried out 23 executions using lethal injection. Our

Due to the shortage of sodium thiopental, the Department of Corrections was required to locate a supplier outside the United States. We lawfully acquired the chemical by working with U.S. Customs, the Food and Drug Administration and the Drug Enforcement Administration.

Throughout the process, the Department of Corrections documented explicitly that our purpose was to use these chemicals to perform executions by lethal injection.

The Arizona Department of Corrections is considering the use of alternative chemicals and protocols to ensure there is no disruption in carrying out the law.

We will continue with the use of a lawful chemical protocol. Any changes will be determined after a full and comprehensive review with the assistance of our attorney general. - Charles L. Ryan, PhoenixThe writer is director of the Arizona Department of Corrections.

# Arizona death-row inmate execution set for May 25

PHOENIX - The Arizona Supreme Court on Tuesday issued an execution warrant for a man who has been on death row since 1985 for raping and suffocating a 13-year-old girl in Tempe.

The high court scheduled 56-year-old Donald Edward Beaty's execution for May 25 at the state prison in Florence over objections from his attorneys about the lethal injection method that will be used against him.

They had argued that the court shouldn't order his execution because of lingering questions about the execution drug sodium thiopental, which they said was illegally obtained and unregulated by the U.S. Food and Drug Administration.

The state Department of Corrections hasn't decided whether Beaty will be executed with a three-drug method that includes sodium thiopental or a different protocol.

Corrections Director Charles Ryan told The Associated Press last month that the state would begin using a one-drug method after the execution of Daniel Wayne Cook, but Cook's planned April 5 execution was canceled after he won a reprieve from the U.S. Supreme Court. Ryan said the department was considering a change over "perceived concerns" about the three-drug method.

DOC spokesman Barrett Marson has said there is no timetable for a change.

Beaty's attorneys had argued that in Georgia, the Drug Enforcement Administration seized the state's entire supply of sodium thiopental over questions about how it was imported into the U.S.

Attorneys in Georgia claimed the drug came from a fly-by-night British supplier operating in a gritty London neighborhood.

A U.S. shortage of the drug, the first to be administered during executions, has caused at least five states to seek it in England.

Beaty's attorneys expressed concern over the drug's effectiveness, writing: ``If Beaty is not properly anesthetized by the sodium thiopental before being given the second and third drugs, he will suffocate and experience excruciating pain."

The last inmate to be executed in Arizona was Eric John King, who was put to death March 29 for a double-murder at a Phoenix convenience store. His attorneys failed to get his execution delayed or stopped over arguments about the execution drug, and Cook's attorneys won his reprieve over an unrelated argument that he had ineffective lawyers during his post-conviction proceedings.

# Arizona to issue execution warrant for inmate

PHOENIX - The Arizona Supreme Court has agreed to issue an execution warrant for a man who has been on death row since 1985 for raping and suffocating a 13-year-old girl in Tempe.

The high court on Tuesday granted prosecutors' motion to order the execution of 56-year-old Donald Edward Beaty.

The court has not set Beaty's execution date, but court spokeswoman Jennifer Liewer says it must happen in the next 35 to 60 days under Arizona law.

Beaty's attorneys had argued that the court shouldn't order his execution because of lingering questions about a controversial lethal injection drug.

They argued that the sedative sodium thiopental was illegally obtained and unregulated by the U.S. Food and Drug Administration.
