Please note that the SFPD purchased this equipment using 2009 grant funds, but staff was unable to locate the request or approval date. The San Jose PD received approval to make this purchase from both the 2011 and 2012 grant but we could not locate a 2011 proposal. Lastly, Alameda requested funding in both 2013 and 2014, but they were only approved in 2014. These proposals are attached. At the request of Alameda County, sections of their proposal was redacted pursuant to Government Code section 6254(f) which exempts certain investigative and intelligence information from CPRA disclosure. Additionally, the redacted information is exempt from disclosure under California Government Code section 6254(k) and 6255 and Evidence Code § 1040. The following federal provisions also apply to prevent or exempt disclosure 6 U.S.C.482(e) § 892; and the provisions of the International Traffic in Arms Regulations ("ITAR"), 22 C.F.R. §§ 120.1–130.7. Further, the federal agencies regard the material as falling under 18 USCA § 2512.
